CALENDAR AND SCHEDULE OF JUDICIAL ASSIGNMENT

Explanatory Notes

For BURKE COUNTY, Child Support court will begin at 9:00 a.m. on the 1st and 3rd Thursdays. The presiding judge will commence child support hearings after completing Hickory Hospital hearings on the 1st and 3rd Thursdays.

A single asterisk (*) indicates the judge, date and time for Motions and Magistrate Appeals, and for Civil Non-Domestic Non-Jury matters if any are scheduled.

Adult Drug Treatment Court (DTC) is indicated by: (D). This court is for Criminal Court clients and is typically held in the Newton Justice Center on Fridays from 2:00 p.m. to 5:00 p.m. Specific dates are indicated on the calendar. Although DTC is no longer funded, it will continue until further directed by the Honorable Burford A. Cherry and the Honorable Amy Sigmon Walker.

Emergency Hearings, when court is cancelled, include all secure custody hearings and non-secure custody orders and domestic violence orders that need to return to court.

APRIL 2015

- **Morganton: On Thursday April 2, 2015** - The Honorable Richard S. Holloway will preside over Morganton DVOs and Emergency Relief matters following the conclusion of Broughton Hospital Hearings.
