SITE PLAN: The following are items that may be required per each jurisdiction. Utilities, landscaping, parking, building dimensions, percentage of mpervious surface if located in the water shed area, graphic scale, property lines, easements, loading areas, dirveway entrances and exits, dumpster locations, and service areas.

*CONSTRUCTION DRAWINGS: Drawings include foundation, structural, electrical, mechanical, plumbing, architectual, elevations and appendix B

* FULL SET OF DRAWINGS: Drawings including site plan and Construction drawings.
*NEW CONSTRUCTION: New building being constructed that did not exist prior.

FOUNDATION ONLY: Phase construction that will allow the pouring of footings and construction of basement walls only.

SHELL IN: Phase construction including the foundation, underslab work and all exterior walls and roof only.

*UPFIT: Phase construction including the foundation, shell in, and all finish work to completion.

*ALTERATIONS: Modifing an existing structure.

VANILLA BOX: Completing a space but not receiveing a Certificate of Occupancy due to no tenant.

SAFETY INSPECTION: Inspection performed when changing occupancy classifications or obtaining an ABC license.

TEMPORARY EVENT: Approved event with venders and entertainment that is open to the public.
