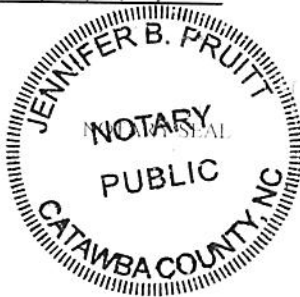

**VERIFICATION BY COUNTY BOARD OF ELECTIONS**
