



TWENTY CHILDCARE CENTERS ACHIEVE "HEALTHY" STATUS

Access To Care



HICKORY, NC – Catawba County Health Partners' Eat Smart Move More Catawba County (ESMM) coalition, in collaboration with Catawba County Public Health's Early Childhood Support Team, recognized twenty local childcare centers for achieving Healthy Childcare Center status through the Healthy Childcare Center Recognition Program.

Now in its second year, the program re-recognized the ten centers that helped pilot the first-year program for achieving Healthy Childcare Center designations a second year in a row: Abernethy's Child Development Center, Community Ridge, Footsteps, Kids in Motion, Miss Millies, Sheila's, Tendercare, The Pa Paw Patch, The Sandbox, and Woodlawn Child Development Center.

Doubling participation this year, the program recognized another ten Healthy Childcare Centers: Bethlehem United Methodist Child Development Center, Christ Church Child Development Center, Hickory Foundation YMCA Child Development Center, Hickory Montessori School, LeGrande Learning Center, Maiden Rosenwald Preschool Academy, Montessori at Sandy Ford, Nanny's Learning Center, Sherrills Ford Learning Academy, and Tyndall Center for Early Childhood. Additional centers will be invited to participate on an annual basis.

The Healthy Childcare Centers Recognition Program focuses on reducing childhood obesity and chronic disease by promoting healthy policies and environments in centers serving young children. The initiative encourages childcare centers to meet the following seven criteria:

1. Childcare center directors and staff (including cooks) are committed to the health and well-being of the childcare center population, act as positive role models, meet monthly, and communicate regularly with parents
2. Offer fresh fruit and/or vegetables at least 3 times per week at lunch and/or snack
3. Offer water daily
4. 100% childcare center classrooms comply with and exceed the minimum state standards for structured physical activity
5. Have in place a childcare center policy for healthy fundraisers and enforce this policy
6. Have in place a policy for decreased screen time and enforce this policy
7. Have in place a childcare center policy for healthy snacks for parties (birthday, holiday, etc.) and enforce this policy

Developed by Eat Smart Move More Catawba County, the initiative was modeled after the coalition's successful Healthy Schools Recognition Program which encourages schools to meet similar criteria.
