CHRISTMAS TREE RECYCLING OFFERED BY COUNTY AND GARBAGE DISPOSAL SERVICE

Wondering what you'll do with your Christmas trees and other natural decorations after the holiday season is over? Catawba County's Landfill staff, in cooperation with Garbage Disposal Service (GDS), has an answer for you. Christmas trees and other natural decorations will be collected at all five Solidwaste Convenience Centers located around Catawba County from December 26, 2011 through January 31, 2012, and at curbsides from January 9 through January 20, 2012. No ornaments, bases or other decorations should be left on trees.

"If you have regular curbside solid waste collection, you may put your used Christmas tree out on the day of your regular garbage pickup from January 9 through January 20, 2012, and a separate truck will come to recycle the tree," said Amanda Kain, Catawba County's Waste Reduction Coordinator. "Since GDS will collect trees at the curbside from January 9 through 20, residents should have two opportunities for GDS to pick up trees on their regularly scheduled garbage pick-up day."

Christmas trees and other natural decorations will only be accepted at the County Solidwaste Convenience Centers between December 26, 2011 and January 31, 2012. Some municipalities in Catawba County are again handling tree pickup separately within their boundaries, so residents of municipalities should check with the government office in their city or town to be sure of the schedule and procedure they should use.

"Since January 1, 1993, it is illegal under North Carolina law to dispose of yard waste in a sanitary landfill," said Barry Edwards, Catawba County Director of Utilities and Engineering. "Christmas trees are defined as 'yard waste', so they may not be disposed of in regular trash containers at any of the County's Solidwaste Convenience Centers".

"All collected trees are recycled to make compost and mulch. The mulch and compost is available to Catawba County citizens at the Blackburn Landfill Construction & Demolition site. Mulch is available for \$10.33 per yard, with a 3 yard minimum purchase which costs \$31, or for \$24 per ton. Compost is available for \$15.16 per yard, with a 3 yard minimum purchase which costs \$45.50, or \$35 per ton. There are no mulch or compost sales on Wednesday," Edwards added.

The County's five Solidwaste Convenience Centers are located on Rocky Ford Road off Highway 10 west of Newton (across from the Blackburn Landfill); Lookout Dam Road in the Oxford Community; Sherrills Ford Road; Bethany Church Road; and in the Cooksville Community on Rhoney Farm Road. The Blackburn Center is open Monday through Saturday from 8 a.m. until 6 p.m. The Oxford and Sherrills Ford Centers operate Wednesday through Sunday from 10 a.m.-6 p.m. The Bethany Church Road Center is open Tuesday through Saturday from 10 a.m.-6 p.m. The Cooksville Center is open on Fridays and Saturdays from 8 a.m. until 6 p.m. All five Convenience Centers will close at 2 p.m. on Saturday, December 24 and will remain closed on Sunday, December 25. Due to the closing on Sunday, December 25, the Oxford and Sherrills Ford Centers will operate on Monday, December 26 from 10 a.m. until 6 p.m. and will resume their regular schedules on Tuesday, December 27.

Christmas trees are accepted at the Blackburn Construction and Demolition Landfill, which will be closed on Friday, December 23rd and Saturday, December 24th and operate on a regular schedule on Monday, December 26th, 2011.
