Sworn Law Enforcement Officer Public Records Exemption Request

North Carolina law (NCGS 153A-98) prohibits the disclosure of information that might identify the residence of a sworn law enforcement officer (LEO). This means the County will take steps to remove information commonly available on the County's website (www.catawbacountync.gov) for sworn law enforcement officers. Addresses will only be removed for property owned wholly or in part by sworn law enforcement officers. For example, the address of a property owned exclusively by the spouse of a sworn LEO cannot be removed.

Catawba County is offering sworn law enforcement officers the choice of whether or not to have your information removed. Upon receipt of your request form (attached), the County will remove your name and address from the following systems:

- Tax Bill Search: <http://www.catawbacountync.gov/Tax/billsearch.asp>

Permit Applications:

- DO NOT apply online as the system will automatically publish your information upon application submission.
- INSTEAD apply in-person with the Permit Center Supervisor.
- ALSO supply a copy of the deed, with the book and page clearly visible, at the time of permit application.
