The Invitation for Bids (IFB) is modified as set forth in this Addendum No. 1. The original IFB documents and any previously issued addenda remain in full force and effect, except as modified by this Addendum, which is hereby made part of the IFB. Respondent shall take this Addendum into consideration when preparing and submitting its Bid Response. Catawba County is issuing this Addendum to provide IFB clarifications.

Clarifications:

1. Catawba County has revised the Bid Form, that was attached to the IFB as Attachment D, to include 150 tons of gravel to recondition the base and reestablish the crown in Windemere Lane. Please use the revised Bid Form included in this Addendum when submitting your bid response.
2. For both Windemere Lane and Shadowfax Wynd Road, wherever tree branches interfere with the scope of work, Contractor can prune the branches back to the trunk. Contractor must dispose of the branches off-site.
3. For both Windemere Lane and Shadowfax Wynd Road, all utilities within the right-of-way are located underground – electric, telephone and cable. In addition, all residences have their own wells and septic.
4. The width of the rights-of-way are 50ft wide except in the Windemere Lane cul-de-sac, which is a diameter of 100ft.
