

STATEMENT OF RESULT OF SPECIAL ELECTION
HELD IN THE COUNTY OF CATAWBA ON
JULY 24, 1962

WHEREAS, by direction of the Board of Commissioners of the County of Catawba, in the State of North Carolina, the following question was submitted to the qualified voters of said County at a special election held in said County July 24, 1962:

- (1) "FOR the bond order authorizing \$4,400,000 bonds to finance the erection and equipment of a new building or buildings to provide hospital and other facilities operated in connection with hospitals, including a nurses home, and the acquisition of a suitable site for said buildings, and the acquisition of existing hospital facilities in Newton, North Carolina, and the site thereof, and the alteration, enlargement, improvement and equipment of said existing hospital facilities for the use of the inhabitants of the County of Catawba, and a tax therefor, not more than \$4,000,000 of the proceeds of said bonds to be used for the purpose of erecting the new hospital facilities and not more than \$400,000 of said proceeds to be used for the purpose of acquiring, altering, enlarging, improving and equipping of said existing hospital facilities"

- (2) "AGAINST the bond order authorizing \$4,400,000 bonds to finance the erection and equipment of a new building or buildings to provide hospital and other facilities operated in connection with hospitals, including a nurses home, and the acquisition of a suitable site for said buildings, and the acquisition of existing hospital facilities in Newton, North Carolina, and the site thereof, and the alteration, enlargement, improvement and equipment of said existing hospital facilities for the use of the inhabitants of the County of Catawba, and a tax therefor, not more than \$4,000,000 of the proceeds of said bonds to be used for the purpose of erecting the new hospital facilities and not more than \$400,000 of said proceeds to be used for the purpose of acquiring, altering, enlarging, improving and equipping of said existing hospital facilities"

and said Board of Commissioners has duly canvassed the returns of the Registrars and Judges of Election appointed to hold said election and has determined the result of said election to be as hereinafter stated, NOW, THEREFORE,

Said Board of Commissioners hereby makes the following

statement of the result of said election, pursuant to the County Finance Act of North Carolina:

- (1) The number of voters registered and qualified to vote at said election was 46, 236.
- (2) The number of votes cast at said election for the bond order described in said questions and for the indebtedness proposed to be incurred by the issuance of the bonds authorized by said bond order was 7,751. The number of votes cast at said election against said bond order and against said indebtedness was 6,734. A majority of the qualified voters of said County who voted at said election voted to approve said bond order and indebtedness.
