CATAWBA COUNTY BOARD OF ELECTIONS

Minutes of meeting held on August 20, 2019

The meeting was called to order at 8:15 A.M. Present were members Barry Cheney, David Abernethy, and David Hood, and the Director. Jason White also participated by telephone. The minutes from August 19, 2019, were approved.

The Director submitted a list of precinct official assignments for a two-year term. Both the Democratic and Republican party county chairs asked the Director to fill any positions not covered by the lists they submitted. All of the available slots for precinct chief judge and precinct judge were filled in the list submitted by the Director. The list was approved as submitted by the Director. A copy of the list is incorporated into these minutes by reference.

The Board passed a resolution for permanently moving the polling place in Precinct number 28, St. Stephens 1, from St. Stephens Lutheran Church, 2304 Springs Road, Hickory NC 28601 to Christ Church – Northside, 2350 Springs Road NE, Hickory NC 28601. The new polling place is within the precinct boundary and is the site of a former large grocery store, with good handicapped voter accessibility and abundant parking space. At the former site, voting was taking place in an outbuilding having inadequate space and lighting within the voting enclosure, among other problems. This resolution will be submitted to the Executive Director of the State Board of Elections.

The meeting adjourned at 8:23 a.m. The next meeting is scheduled at 8:15 a.m. on September 17, 2019.
